ON THE APPLICATION of HSBC Bank Canada, a chartered bank of Canada, with an office at Suite 600, 885 West Georgia Street, Vancouver, British Columbia, V6C 3G1, a creditor of The Columbia Restoration Company Ltd., filed August 13, 2013, coming on for hearing this date at Vancouver, and upon hearing Edward J.T. Wang, counsel for HSBC Bank Canada and upon no other parties appearing;


And it appearing to the Court that The Columbia Restoration Company Ltd., within the six months next preceding the date of the filing of this application for a Bankruptcy Order, has committed an act of bankruptcy as at August 6, 2013, as it has permitted an execution of other process issued against it under which certain of its property has been seized, levied on or taken in execution on July 22, 2013 to remain unsatisfied for fifteen days after seizure, levy or taking in execution, pursuant to Subsection 42(1)(e) of the *Bankruptcy and Insolvency Act* R.S.C. 1985, c.B-3.

THIS COURT ORDERS that:


1. The Columbia Restoration Company Ltd., a company incorporated in the Province of British Columbia under incorporation no. BC0651063, having a registered office located at 5690 – 176A Street, Surrey, British Columbia, V3S 4H1 and carrying on business at 101 – 5219 192nd Street, Surrey, British Columbia, V3S 4P6 be adjudged bankrupt and a Bankruptcy Order is made against The Columbia Restoration Company Ltd. (the “**Bankrupt**”).

2. Mario Mainella of The Bowra Group Inc. of Suite 430 – 505 Burrard Street, One Bentall Centre, Vancouver, British Columbia, V7X 1M3, be and is hereby appointed the Trustee (the “Trustee”) of the Estate of the Bankrupt.
3. The Trustee give security in an amount to be fixed by the official receiver under section 16(1) of the BIA.
4. the costs of and incidental to this application for a Bankruptcy Order be paid to the Applicant out of the assets of the estate of the Bankrupt upon assessment of its costs.
