Re: In the Matter of the Bankruptcy of Tri-Ag Implements Ltd.

On February 10, 2020, Tri-Ag Implements Ltd. (the "Company") filed a Notice of Intention to Make a Proposal ("NOI") pursuant to Section 50.4(1) of the *Bankruptcy and Insolvency Act* (the "BIA"). The Bowra Group Inc. consented to act as Licensed Insolvency Trustee (the "Trustee") in the proposal proceedings. On March 10, 2020, the Company applied for and received an Order from the Court of Queen's Bench of Alberta extending the time to file a Proposal to April 24, 2020. The Company did not file a Proposal by April 24, 2020, and as such was deemed bankrupt on April 27, 2020. The Bowra Group Inc. was appointed Licensed Insolvency Trustee in the Bankruptcy.

The First Meeting of Creditors is a formality in the Bankruptcy process and its purpose is to affirm the Trustee's appointment, appoint inspectors to the Bankrupt estate and to provide the Trustee with directions in carrying out the administration of the estate. In order to be eligible to vote at the meeting of creditors, creditors must have completed and submitted a properly executed proof of claim prior to the start of the meeting.

Please note that creditors are not obligated to attend the meeting and that a creditor's non-attendance does not impede its ability to file a proof of claim and participate in the distribution of any dividends that may become available upon completion of the administration.
