Re: In the Matter of the Bankruptcy of Tri-Ag Implements Ltd.

On February 10, 2020, Tri-Ag Implements Ltd. (the "Company") filed a Notice of Intention to Make a Proposal ("NOI") pursuant to Section 50.4(1) of the *Bankruptcy and Insolvency Act* (the "BIA"). The Bowra Group Inc. consented to act as Licensed Insolvency Trustee (the "Trustee") in the proposal proceedings.
